First Christian Church Members and Visitors,

I hope that you are safe, staying home as much as possible, and have done whatever you can to protect yourselves in this time of self-isolation. This is an unprecedented time. I cannot remember a time when the church urged congregants to stay home from worship; however, I do thank God for the ability to share in worship through online platforms. You can participate in the services we have placed on Facebook and Twitch. Soon they will be up on our YouTube channel as well. If you are having difficulty finding our services please let us know. On Thursday of last week, Governor Kay Ivey issued a statewide health order prohibiting gatherings of more than 25 people in a room that cannot keep a 6-foot distance. This order will be in effect until April 5. This means that our worship services for March 29 and April 5 will be suspended along with all of the meetings or events regularly scheduled during the next two weeks. Once again, after April 5, church leader-ship will make a decision, based on information at that time, as to whether services can resume.

This means that we will not be able to worship together on Palm Sunday. It is my hope we can celebrate Maundy Thursday and Easter together, but we will continue to follow the advice of medical professionals and the state to keep our congregation and community safe.

The church office will remain open Monday through Friday from 9:00 am until 5:00 pm. We have one staff member at the office every day so we can answer the phones and take care of work that can only be done in the office. Our other staff members are working at home. The Journey is still going out weekly, services are still being planned, and we are still holding some meetings through online platforms. If your group our like to meet in this way we can connect you with a platform that will accommodate you. You will still be able to contact Rev. Laura West and me by phone, text or email, however, we will not be visiting in person unless it is an emergency situation and the member or family requests our presence.

Our Mission Family Deacons and Elders continue to contact our members, especially those who are most vulnerable, to ensure that our community is cared for in the absence of our regular worship and fellowship events. Please let us know your needs and continue to pray for those in our community and in the world that have already been affected by this virus. We also have volunteers who will pick up groceries, supplies, or prescription medications for those who are at risk.

I urge you to stay safe, stay home as much as possible, and limit contact. We can continue to pray for each other and the world, trusting that God will see us through this life-changing time. Let us continue to keep our first responders, health professionals, and all those who work to keep us safe in our prayers as well as asking God to help remedy this situation globally.

## **CHURCH SAFETY IMPROVEMENT**

To make our Sunday worship safer and more secure during worship service times, we will begin locking the north side door (by the Church Office and currently designated as "Sunday Entrance") shortly after we resume church services. That is, from 8:15 a.m. until 9:15 and from 10:30 until 11:30 this door will remain locked. Additionally, this door will remain locked during any combined service, as well. However, the door will be unlocked and monitored during Sunday school time - 9:15 until 10:30 and during the adjusted Sunday school times associated with a combined service. The exterior Narthex doors leading into the Sanctuary will remain open throughout Sunday morning. This measure is not intended to inconvenience anyone; we want our church to be open and welcoming, but we also want to keep our children, members, and guests safe.
